

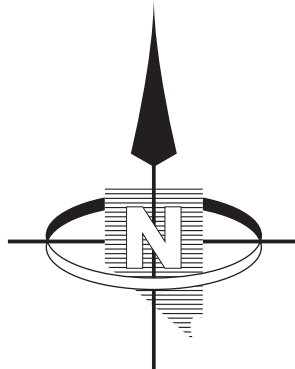
Marlette Lake Dam Resilient Infrastructure Project

BCA 6 – Average Annual Daily Traffic

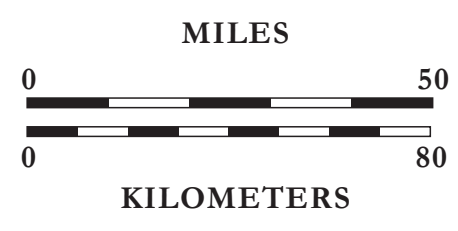

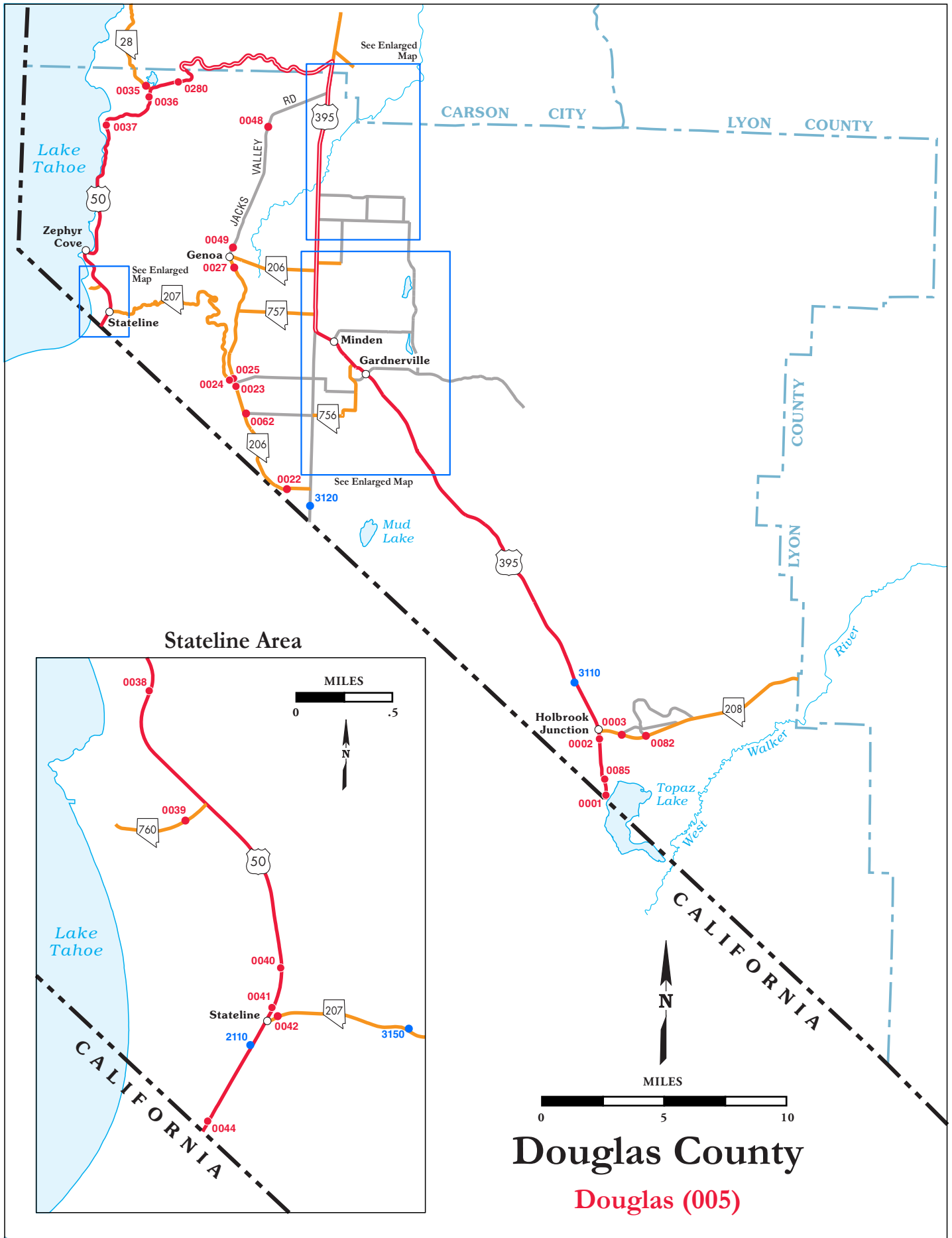
